Assistance is granted on a case by case basis and limited by the money we have available for this purpose. Unfortunately, we cannot grant assistance to all who apply for it, as the funds for assistance are limited.

A small committee reviews all the applications. The committee consists of the Vice President of Finance & Development, the Board Trustee with responsibility for this area, the Executive Director, members of the Finance Department, and any others who are called in to assist. All arrangements made are individualized and expected to be kept confidential.
